Vaughn Hills form one of the highest land areas between Boston and Mount Wachusett. Trails circle the North Peak **1** which is second only to Wattaquodock Hill as the highest point in Bolton. Several routes lead to the summit. The South Peak is on private land. Vegetation varies greatly from pine forests, to oak scrub, to stands of birch and beech. Of special interest is the huge beaver dam frequented by birds and other wildlife. In the spring, herons and ospreys nest in the pond's dead trees.

The Hansen Property consists of an upland pine forest bordered by a brook on its western edge. A cart path leads into the property and ultimately to Vaughn Hills. This path passes the site of the old Sullivan cabin where there is a marker and a bench.

The Held Trail follows along the wooded edge of open fields and provides a connection between the Vaughn Hills/Hansen land and Bowers Springs. The trail is named after Rob Held, one of the leaders of Bolton's conservation work from the 1970s to the 2000s.

The Moen Property is a wooded area with a pleasant valley and connections to Harvard conservation land. It was acquired by the Town of Bolton with receipt of grant from Executive Office of Energy and Environmental Affairs (EEOA)

Parking:

- **Vaughn Hill Rd.** The Moen Parking area. Space for 4 cars and a kiosk where maps and information are displayed.

- **Green Rd.** 2 carefully parked cars at the start of the cart track. Another car can be parked on the shoulder not impeding traffic.

- **Woodside Drive cul-de-sac.** 2 cars along the shoulder, not impeding traffic. Please do not block the driveways of the nearby houses.

Connections:

Bowers Springs ([map 3](#)) via the Held Trail and/or the Bartsch Connector.

Bolton Flats Turn right from the Moen parking lot on to Vaughn Hill Rd. At the junction with Still River Rd. turn left and continue to the Red Barn ([map 1](#)).

The Bolton Loop Trail passes through this area. For more information, contact the Trails Committee.

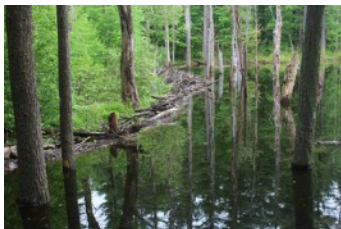
Viewing:

Bolton Conservation Land Rules and Regulations.

The areas of Bolton Flats (Map 1) and Delaney Wildlife Management Areas (Map 7) fall under the Massachusetts Division of Wildlife regulations. Additional details can be found at:

The Bolton Conservation Commission welcomes responsible public use and enjoyment of land under its stewardship. Pursuant to Massachusetts General Laws Chapter 40, Section 8c, the Conservation Commission has adopted these rules and regulations to protect:

- Surface and groundwater resources
- Unfragmented forest habitat
- Wildlife habitat
- Open space and the trails system.

Prohibitions

- Hunting, trapping and discharging of firearms, arrows, paintballs, and pellets
- Motor vehicles, except for emergency response or municipal vehicles
- Dumping and/or littering
- Alcoholic beverages and glass containers
- Smoking
- Swimming except by attendees at the Tom Denney Nature Camp.

Advance permission needed in writing from the Bolton Conservation Commission for the following:

- Camping
- Fires
- Memorials or Displays
- Building new trails, extensions, and modifications to existing trails
- Cutting, removing, or damaging vegetation, except for the control of invasive species
- Collecting dead or downed wood, rocks or wildlife.

Any activities or uses not set forth here require the prior written permission of the Bolton Conservation Commission.
