# **Trust meeting - Drew**

- Vespa property CR is in progress.
- Hazel property is almost getting closed with signage and trail creation.
- They reached out to NE Power, but it will be slow.
- Wilder Pond bridge was discussed.

#### Hazel

- A little bit of arrows are done. Gordon has ordered to print waterproof maps that are for 5 locations from Clinton offset.
- We need to place the signs but, Bob is busy so, October would be the best time.
- Signs will be approved at Select board meeting.
- In past Gordon and Betsy were able to park but due to pile of material, parking is not possible. We would want to move it if we want to get a parking space. It is Trust land so, DPW might not be able to help. Someone named Mr. Goldie might be able to help. Keith is away otherwise he could help us.

### Rattlesnake Bog Bridge - Bob

- Bog Bridge is done as Bob sent a picture to Gordon with Boy Scouts standing on the bridge.
- West Great Brook Bridge on the Horton Trail Material is at Bob's house apart from telephone poles and another Boy Scout named Alex Dow who wants to do an Eagle Scout project.

### Wilder

- Bridge Repair Chris, Larry, Keith; Drew has been working on this with ConCom.
  - Drew shared that we have DEP file number and waiting for order to be submitted. Bob Hatch will start to order material. We would need volunteers for this bridge.
  - There is no plan on how to move/remove old bridge. Drew mentioned that we could use tractor to haul it to the road or bring it to another spot. DPW can't put into any

bins. Other option is to break it and leave it in place like Annie Moore. Rebecca had to pay to move it.

• Pile can't be left there as it is by the high way and a safety hazard.

# **Bowers-Larry**

Invasive Sessions

- Larry has been on vacation. He is planning to restart Bowers invasive work using brush hog.
- Larry finds it hard to get the key for brush hog when he has time if Town Hall is closed. You have to plan in advance. Gordon asked to talk with Lauren or Marie who is the Town administrator.
- There was a report to Lauren about a large wasp nest at Bowers; has anybody seen it? After speaking with DPW I've learned that this is an underground nest of Cicada Killer Wasps along the edge of the parking area (photo attached). They are typically non-aggressive unless agitated. DPW tried treating the area but were unsuccessful, and the highway staff has cordoned off the area for the time being. This is a discussion item that has been added to the 8/5/25 ConCom agenda to see how the Commission would like to proceed with dealing with them.

#### Hikes

- Hemali is planning a hike in August for AMC. She will share that once it is posted.
   Tentative date is given for August. Two miles is about good distance for hikes.
- Chris mentioned about path with bailout plan so, some people can leave early.

### Wildflower walk document - Hemali

 Should the Trust publish a hard copy (suggestion from Bob)? Maps on plastic for use at the Trailhead have been ordered by Hemali.

- The plastic maps are gone. Gordon has ordered waterproof maps on material that is used for menu and it is easy to wipe and clean and reuse. It is 11 by 17 and are foldable.
- There are currently 3 at Rattlesnake assuming no one has stolen yet. These are not cheap. They are about \$4 each.

# **Approved projects**

- Rattlesnake/Skinner Land Bridge Repair on Sawyer Grist Mill path
  - We have discussed about this. Drew would work on it when he has time. It is simple project. It has been also offered to an Eagle Scout.
- Welch Pond Trail to Sawyer Road Gordon and Drew. Needs maps and signs, Gordon has started marking the limits of the available land.
  - This was offered to another Eagle Scout who is interested to do a project. Gordon
    and Betsy went with him and walked to the point where the trail connects to the
    Pond Trail. They have put a lot of tapes based on GPX. He likes this project. Ken is
    interested in this project as well especially when we put a sign calling private
    property where his property starts.

# **Vinger Venable Route modification**

This project needs ConCom approval. Gordon to assemble a map and reasoning; no progress.

- There is no update on this project.
- If you go from Berlin Road, there is a drive way, trail comes too close to the house. Suggestion is to go a bit more along the road but since there is wet land area, it requires approval. Route is not approved yet.

### Storage

### Vaughn

- Unauthorized mountain bike jumps.
  - Note from Lauren: On 6/3/25, ConCom voted to authorize the posting of the proposed signs that were presented during the meeting in the Vaughn Hill Conservation Area in locations determined as necessary by the Conservation Agent/Land Use Admin Assistant. Both authorized signs are attached and may be posted in specific locations. Please feel free to contact me regarding sign posting locations.
  - It was mentioned that the signs need to get spelling errors fixed.
- Trail re-routing near the Moen entrance; do we need to do anything? Rebecca. Probably not much has happened
  - When you go to Moen and go towards the left at the end, you might see wet area in spring. Rebecca had said that we will reroute that but nothing else has happened after that.
  - Chris said that people have started to use another path to avoid the muddy path.
