Trust meeting - Drew

- They discussed what to name the new conservation area near Hazel land that is recently acquired. Since Smith property will connect with Hazel property and Levison property and then connects to Northwoods. Bob will help with the sign. Drew will get permit for the sign so, it can be installed.
- Vespa property agreement is being drafted so it can be protected with a CR.
- Drew contacted New England Power company multiple time without success.
- Wilder is moving forward.

Hazel

- Trail is completed (well done Drew) and online map updated by Gordon ready for review (click <u>here</u> or here <u>https://boltontrails.org/wp-content/uploads/2025/07/5-Zink-Northwoods-Jul-2025-draft.pdf</u>
- Some arrows, new and updated trailhead maps (new ones at Warner Rd and the Hazel Trail Junction), and signs are needed. Gordon has some frames. Maps can be released when approved. Please let Gordon know if you are happy with them. Perhaps we can use the plastic menu material that Hemali for the trailhead maps. It might be more resilient than a laminated paper print out method; worth an experiment maybe?
- Note the addition of a parking space on at the no longer "orphaned" Smith conservation triangle on Warner Rd. Is this OK?
- We discussed that Warner Road parking is just one spot. Since Rebecca is not here
 who would help with additional parking spot approval process. Would it be Lauren or
 Town Administrator.
- Bob said to send to Lauren and copy Randy and Mary.

Rattlesnake Bog Bridge - Bob

 Bog Bridge Eabhan Ambrose's Eagle Scout project plan for the Rattlesnake bog bridge has been completed and signed by Rebecca. It's planned for June & July, if weather is good. The material has been delivered to Bob's home.

- Bob will meet with Eabhan this week. He will work with troop to cut the material. Rest is straight forward.
- West Great Brook Bridge on the Horton Trail Max Roemer was re-nailing some loose planks that had lifted when Cub Scouts walked along the edge; he realized the tops of the telephone poles were completely rotten. Suitable wood has been found by Chris Slade. The rest of the material has been delivered to Bob's home. This is unlikely to be an Eagle project and some strong volunteers will be needed.
- Bob said that Chris Slade said that marine piling is not going to work but he has
 found telephone poles that were broken off at the base that would work for the
 bridge. Bob has everything else ready to go. Annie Gherkins grand son is tall and
 strong. He would be able to help move material on other side of the bridge.

Wilder

- Bridge Repair Chris, Larry, Keith; Drew has been working on this with ConCom.
- We have to refile this project as we are reducing length of bridge to 20 feet. They are concerned about light penetration and impact to resource area. No other issues during public hearing.

 has some knowledge about historical trails in this area and might be available to
 show us the route(s). Trails planned. Volunteers and BTC will be needed for clearance
 of the pathway once flagged.
